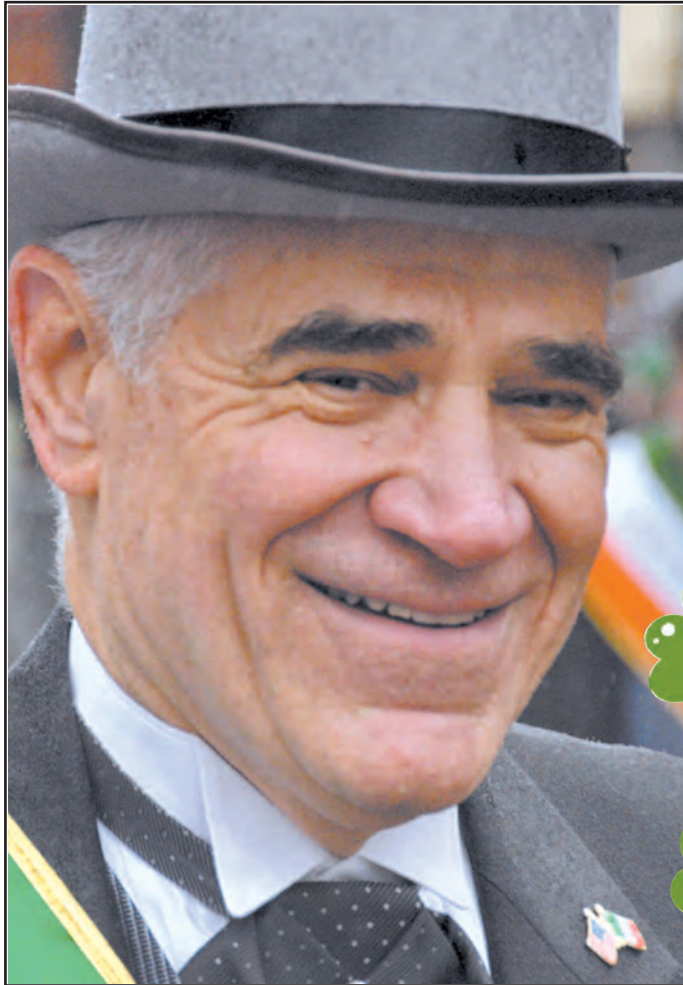

Hon. W. Gerard Asher Is At The Head Of The Parade

The Honorable W. Gerard Asher is better known to his family and friends as Jerry. He was born in Mineola in 1941 and moved to Huntington at age 13. Ever since, he has been thoroughly engaged as a proactive citizen in Huntington. He graduated from Huntington High School in 1959, where he was president of the senior class, captain of a championship football team, and team captain of the basketball team. He went on to graduate from Princeton University in 1963 and Cornell Law School in 1966.

Jerry served two years in the U.S. Army. As Captain, he was Commander of a Hawk Missile Battery in Korea in 1968, for which he received an Army Commendation Medal. He is a lifetime member of VFW 1469 and Post 360 of the American Legion.

In 1969, Jerry returned to Huntington and began a general practice of law, with an emphasis in Real Estate, Surrogate Law, Litigation, and Sports Law. He was certified by the

MLBPA as an agent for Major League Baseball players working for and with Tony Atanasio. In 36 years of practice, Jerry served on numerous SCBA Committees, received two Pro Bono Awards, was a member of the SCBA Board of Directors, and was President of the Huntington Lawyers' Club from '82 to '83. Throughout his career, he served on numerous community charitable and government organizations. Some of these included his 48-year membership in the Kiwanis Club, where he was twice a distinguished President and a Hixon Award winner. He was an initial selection of a Congressional Achievement Award in 1984 for community service to Long Island. He was also a six-year member of the Board of Directors of the Huntington Township Chamber of Commerce, Chairman of the Suffolk County Legislature Redistricting Committee, and on several Blue Ribbon Committees for the Town of Huntington. Jerry was a dedicated member of the Hunt-

ington Planning Board for 17 years. He also has been a trustee of St. Anthony's High School for over 20 years.

In 2004, Jerry was elected to District Court, where he tried numerous criminal matters, and was the Drug Court Judge for Suffolk County for two years. He was selected as Judge of the Year in 2009 by the Suffolk County Criminal Bar Association. In 2010, Jerry was elected Justice of the Supreme Court, serving in a Civil Part.

The Asher family has been members of St. Elizabeth RC Church for over 47 years.

Jerry has been active in numerous ministries at St. Elizabeth's over the years and currently serves as a Lector EEM and member of the Parish Counsel.

Jerry has been married to his high school sweetheart, Sylvia, for 56 years, and they are the proud parents of two adult children: Gigi and Lara.



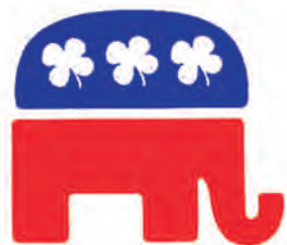

LI's Largest and Oldest St. Patrick's Parade

The Ancient Order of Hibernians (AOH) Division 4 will host its 86th annual Huntington St. Patrick's Day parade on Sunday, March 8, 2020. The parade kicks-off at 2 pm near the Huntington LIRR train station and proceeds north along New York Avenue (Rte. 110) before turning west onto Main Street (Rte. 25A) and ending at St. Patrick's Church.

This grand parade has a rich history dating back to the early 1930's when the nation was in the grips of the Great Depression. *Finnegan's* opened the day after Prohibition ended to cater to the growing population of Irish workers. Down the street, *Valencia Tavern* opened on the very same day to cater to the Italian laborers.

Although times were tough, a great community tradition was started when the entire town came together to celebrate the first St. Patrick's Day Parade held anywhere on Long Island.

Eighty-six years later residents continue to celebrate the unofficial start of spring on the second Sunday of March when the St. Patrick's Parade marches through Huntington village. On Sunday, members of the Irish-American fraternal organization the Ancient Order of Hibernians will again march dressed in their distinctive gray morning suit tuxedos.

At the head of the parade will be Grand Marshal Honorable W. Gerard "Jerry" Asher leading bands, schoolchildren and

scouts, fire departments and community groups to the reviewing stand at the western end of Main Street.

The core of the parade is of course the bagpipe bands and no parade on Long Island can match Huntington's lineup. Pipe bands from all over the Island and New York City consider Huntington to be one of the finest parades around. This year the parade will include an impressive 19 pipe bands, including Clann Eireann Irish Pipe Band, the parade's lead pipe band for decades. Brooklyn-based Clann Eireann is the oldest, continuous independent Pipe Band in the United States. New York City's world-class NYPD Emerald Society Band and the famed Northport Pipe and Drum Band are among the kilt-wearing, bagpipe-playing marchers that will delight thousands of spectators on the parade route.

This year brings some exciting new parade participants, and the return of Empire State Snow Dogs Association with 100 snow dogs. "Mush!"

Ancient Order of Hibernians members are proud to have their brother the Honorable Gerard Asher lead the division down the streets of Huntington as the Grand Marshal. Alifettime Huntington resident, and active community member, Justice Asher is retired from the NYS Supreme Court in Suffolk County.

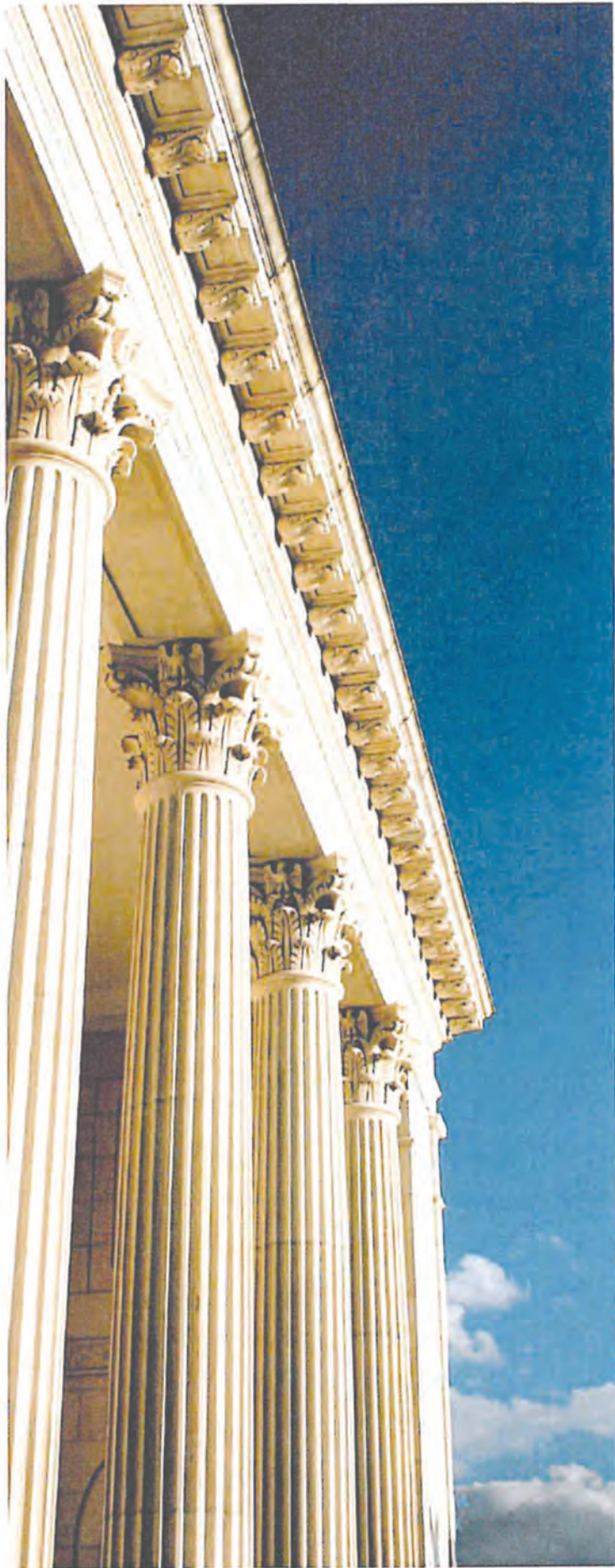

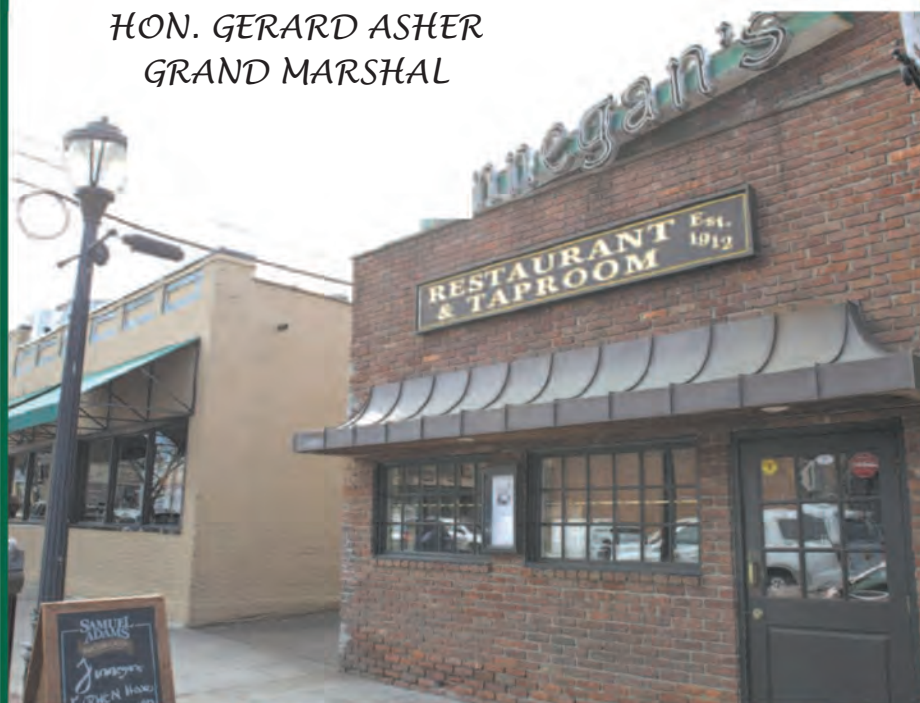

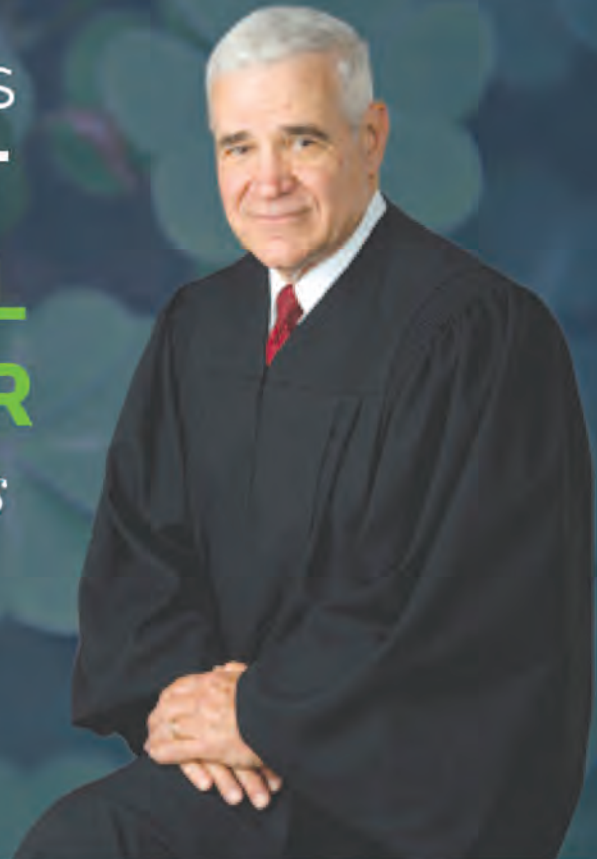
